The infrastructure of the Šiauliai remand prison was built more than 100 years ago and has never been significantly renovated, accordingly, its functionality, operational characteristics, compliance with the established regulatory requirements lead to decreasing opportunities to carry out the activities of the Šiauliai remand prison.





### Selection of a Private entity procedure



**On 11 July 2022**, The Government of the Republic of Lithuania approved the decision that the project will be implemented as the Public-Private Partnership. <u>Government decision</u>.



### PRELIMINARY QUALIFIACTION REQUIREMENTS (I)

The candidate must be <u>financially capable</u> of financing the Project. The total amount of funding, including the Funder's contribution, together with the financial contribution of the Participant must be no less than EUR <u>36 700 000</u> (thirty-six million seven hundred thousand)



# PRELIMINARY QUALIFIACTION REQUIREMENTS (II)

- The scope of construction of <u>public and / or special conditions</u> new buildings or reconstruction of the Candidate during the last 5 (five) years before the deadline for submission of applications or within the time from the date of registration of the Candidate (if the activity is carried out for less than 5 (five) years) till the deadline for submission of applications must be at least <u>25 700 000</u> (twenty-five million seven hundred thousand) Eur (excluding VAT) (or in respective another currency).
  - The execution of the works and the final results must be recognized as properly completed.




### PRELIMINARY QUALIFIACTION REQUIREMENTS (III)

The scope of <u>public and / or special conditions</u> buildings management and maintenance services of the Candidate during the last 5 (five) years before the deadline for submission of applications or within the time from the date of registration of the Candidate (if the activity is carried out for less than 5 (five) years) till the deadline for submission of applications must be at least <u>800 000</u> (eight hundred thousand) Eur (excluding VAT) (or in respective another currency).

# REQUIREMENTS RELATING TO CLASSIFIED

An entity that is not registered or has declared a place of residence (a natural person) in a Member State of the European Union or NATO, may not be a candidate / subsupplier.

The Private entity shall comply with the requirements of classified information protection: has clearance to enter into contracts classified as "limited us of information"



#### DIALOGUE

#### The following conditions shall not be changed:

- larger annual payment (discounted values) than 53 245 963 euros;
- the issues of the property rights of the property Transferred for the performance of the Agreement or property that was newly created during the performance, or Land plots, after the expiration of the Agreement;
- Duration of the construction period (3 years);
- Duration of the contract period (15 years);

- Larger buildings area of Šiauliai remand prison than 16 232 sq. m.;
- the principle of determining the maximum amount of compensation paid to the Private partner (the value of the property, which is appraised by the independent property appraiser in accordance with the legal acts of the Republic of Lithuania), when the Agreement is terminated due to the fault of the Investor and / or the Private partner.



#### COMPETETIVE DILOGUE STAGES

I STAGE. Technical aspects of the Solutions (engineering and technical solutions, provision of services, handed over to the Private partner, Project results according to Specifications, Object creation, service provision and contract management plan; other matters associated with the technical aspects of the Solutions).

**II STAGE.** Financial aspects of the Solutions (sources of funding and funding conditions, terms of settlement and payments, tax issues, other issues related to the financial aspects of the Solutions).

**III STAGE.** Legal aspects of the Solutions (The draft Agreement and its annexes; risk sharing between countries, other issues related to the legal aspects).
